1. Information We Collect

We may collect the following information when you use our Site:

- **Personal Information:** Name, email address, shipping/billing address, phone number, and any information you provide through forms or contest entries.
- **Payment Information:** Credit card or debit card details, processed securely through our payment processor, Stripe. We do not store your full credit card information on our servers.
- **Contest Information:** Submissions to our recipe contest, including recipe content and any accompanying materials. Your name and contact information will remain secure and not be publicly shared without your consent.
- **Technical Information:** IP address, browser type, device information, and site usage data, collected automatically for site functionality and analytics.

2. How We Use Your Information

We use the information we collect for purposes including:

- Processing and fulfilling orders.
- Processing secure payments through our merchant account.
- Managing and administering our recipe contest, including publishing submitted recipes in our recipe section (with personal identifiers removed unless you provide consent).
- Communicating with you about orders, promotions, or updates.
- Improving our Site, products, and services.

3. Sharing of Information

We do **not sell, rent, or share your personal information** with third parties, except in the following limited circumstances:

- **Payment Processing:** To our merchant, for secure payment transactions.
- **Legal Compliance:** If required to comply with applicable law, regulation, or legal request.
- **Business Operations:** To trusted service providers who assist in operating our Site, provided they agree to keep information confidential.

4. Data Security

We implement reasonable administrative, technical, and physical safeguards to protect your personal information. Payment information is encrypted and processed via Stripe, a PCI-DSS compliant payment processor. While we strive to protect your information, no method of transmission over the Internet or method of storage is 100% secure.

5. Children's Privacy

Our Site is not intended for individuals under the age of 13, and we do not knowingly collect information from children. If we discover that we have inadvertently collected information from a child, we will promptly delete it.

6. Your Rights and Choices

You may:
